HIGHLIGHTS OF THE 2016 AGM

The LFL-C Annual General meeting took place on Saturday, Nov. 12, 2017, at Faith Lutheran Church in London, ON. The morning began with registration, refreshments, muffins and fruit, followed by Devotions and a timely message delivered by Pastor Oscar Castillo. There were 34 registered participants.

Marian Obeda, a long standing member of the Board introduced the guest presenter, Alex Schadenberg, the Executive Director of the Euthanasia Prevention Coalition,. Alex pointed out the media brainwash on Euthanasia, "ending suffering". And stressed "safeguards" were not very reliable due to judgement calls of others in authority. This was further demonstrated in



the viewing of the DVD "The Euthanasia Deception" a film that exposes three main deceptions; that euthanasia is a form of compassion; that decisions made between the

doctor and patient operate in a vacuum and finally can safeguards protect the vulnerable? The film included testimonies from those whose family members were euthanized and on one

that was involved in performing euthanasia.

During Lunch break Marian Obeda presented Rev. Michael Salemink, the Executive Director of



Lutheran's for Life in the U.S., with some thoughtful gifts, served with humour, on behalf of the LFL-C Board, as reminders of his trip to Canada. Lunch was made and served by the London ladies. There was also a beautiful cake, decorated with the Canadian flag, to honour the occasion. Later, Rev Salemink shared with the group how he started out and got involved with LFL. The Voting Members meeting was chaired by Pastor Rick Juritsch, as President Cliff Pyle was unable attend.

Nominations and elections for 3 directors took place and Pastor Rick Juritsch and Pastor Gregory Palmer were re-elected with newcomer Adrian Rhodes.

Pastor Rick Juritsch announced the news that Marian Obeda was resigning from the Board. On behalf of the Board, Pastor Rick Juritsch thanked her for all her dedication and hard work over the years. Marian Obeda was honoured with a standing ovation by all the Board and voting members. She will continue participation in other areas.

The meeting closed with devotions and installation of Board members by Rev James Luke.

HOW MANY PEOPLE HAVE DIED IN CANADA BECAUSE OF EUTHANASIA?

A simple answer about how many people have died is not easy to find. Since we are always hearing of campaigns to 'legally permit' euthanasia in different jurisdictions, it is strange that euthanasia enthusiasts don't trumpet their body counts.

To that end, I researched the death numbers from the Internet. The first realization is that there is no global clearinghouse (at least as of early 2016) of the death numbers in places where medical killing was legally permitted. The second realization is that the numbers, when found, do not provide a clear picture.

In fact, the numbers, as I found them, are used to push forward an agenda of death acceptability, rather than highlight any greater idealistic truth. Therefore, there was, until I created this, no collection of data showing the numbers worldwide.

The answer to the question posed in the title is that approximately 788 people have been medically killed in Canada, as of January 23, 2017. This is based on media reports, gathered over time, and those reports are self-contradictory and therefore are incomplete.

To answer the question over euthanasia deaths worldwide, the approximate number of people killed is 59,000. This is another under-estimate, since Switzerland, India and Columbia have not been included in those totals.

There is another issue with the numbers: the reports given over time do not add up. There is a variance in the reported numbers from time to time as the numbers are released by province. The issue with these numbers is that they are snap-shots; they are not cumulative over time.

With the variance in the provincial numbers, we do not know which numbers are accurate. This is another mechanism that leaves Canadian citizens in the dark.

Then there is Bill 84, presented in Spring, 2016. This Ontario Bill specifically said that the public had no right to know how its citizens were killed in that province. This covered in the Bill, in Section 65 of the Freedom of Information Act:

So not only does someone have a right to be killed (to save money, according to the Globe and Mail of January 23, 2017) the public has no right to know who has been killed in Ontario, even though the deceased was killed with taxpayer dollars. There is also no provision in law about how sanctions would be levelled at doctors and nurses who broke the law. It's a self-reporting issue in any case; what doctor is going to self-report abuse?

This should be a cause for concern; the position that the public has no right to know what is happening erodes the legitimacy and role of the public citizen. It also removes any possibility for resistance to euthanasia by silence. Even worse, silence on the issue equals consent.

If silence equals consent, then voicing concerns equals dissent, and dissent in the ending life game is not allowed. (Virilio, 2003:74) If you want to see one possible future of the discourse, note how people who are against abortion – even for what we might see as

'trivial' reasons – are marginalized and silenced. This is why people who are against medically imposed death but are silent no longer have the ethical right to keep silent.

To make matters worse, some 'medical ethics' specialists are arguing that medical professionals do not have the right to exercise their conscience. (Udo Schuklenk blog, March 25, 2015)

The implication is clear, even from this cursory examination: the public's right to know how their safety in care is compromised when such basic information (how many people has your government killed in the name of compassion?) is essentially made a state secret is abrogated to a different ideal.

And those same public servants who have misgivings do not have any right to refuse to participate in the killings. In short, we have seen how there is a socially sealed environment that steers someone to death as if medically imposed death were automatic and therefore, inevitable. This secrecy means that abuses will happen, but the victims will be silenced and rendered invisible. This cannot be a protection for the patient/victim, it must therefore be a protection for the organization. This is why medically imposed death is, at the same time, an ideological benefit to its supporters, and a deep betrayal of the vulnerable.

So what do we need to do to protect the vulnerable patients at risk of medically imposed death? First, we need to remember the Gospel truth: nothing is covered that will not be revealed. (Matthew 10:26, ESV) We will find out this truth, however we find the information on imposed deaths. There might be a momentary scandal and emotion, but the majority of people will let it go. This must not happen.

We know that some of us can take on the role of a watchman, as in the OT requirement:

But if the watchman sees the sword coming and does not blow the trumpet, so that the people are not warned, and the sword comes and takes any one of them, that person is taken away in his iniquity, but his blood I will require at the watchman's hand. (Ezekiel 33:6, ESV)

In warning in this way, that medically imposed death is a scandal and an anarchy, we are fulfilling the role of watchman. Note that we are not required to succeed in stopping evil; we are to at least try to warn about the evil we see.

We cannot therefore keep silent on medically imposed death, when we see this wrong. We might not succeed when we stand up and warn of danger; it is possible that we might even pay a price for such a statement. However, if we do stand up, publicly, against medically imposed death, others will see what we do and be encouraged themselves to resist this evil action in their own way.

Furthermore, by standing for life, by spreading the Gospel in this action, we are fulfilling our mandate to evangelize, and in our current social and medical context, the best evangelization is to remind people that they do not have to accept the world's argument and rule that medically imposed death is the best action in it.

WHAT THE BIBLE SAYS ON PHYSICIAN ASSISTED SUICIDE (EUTHANASIA/MURDER)

In response to more requests for Biblically-based guidance on what should properly be called physician assisted murder I offer the following:

God's views on 'euthanasia' and the sinful views of men.

Recently a number of people have contacted me and asked my Pastoral advice on euthanasia. They have been disillusioned with secular commissions, associations, and even non-Biblical church bodies. They're confused, disappointed, and rightly so. The ultimate and only authority on issues of life come from God, and His inerrant Word, the Bible. In Luther's Small Catechism with Explanation we find God's answer to this question in which we can find instruction, comfort, and hope: "The severely handicapped, infirm,

helpless, and aged are persons in the sight of God with life given by Him and to be ended only by Him."

What are Bible scriptures we can look to? Proverbs 6: 16-17: "There are six things the Lord hates, seven that are detestable to Him: haughty eyes, a lying tongue, hands that shed innocent blood." We can also look to Proverbs 31: 8, "Speak up for those who cannot speak for themselves, for the rights of all who are destitute." Another Bible verse for guidance is Acts 17:25, "He Himself gives all men life and breath and everything." We need look no further than the first verse of Genesis in the Bible to see this is true.


lives. Each one of those abortions is a tragedy, not just because an innocent child died, but because of the lasting impact the abortion itself had on the mothers of those children.
